SACRAL NERVE STIMULATION (INTERSTIM THERAPY) PREPARATION INSTRUCTIONS

InterStim therapy involves electrical stimulation of the sacral nerves. The sacral nerves are in the lower area of the spinal cord (over the tailbone). These nerves affect bladder and bowel function. Stimulation of these nerves with the InterStim device can change/alleviate the symptoms of fecal incontinence. InterStim is done in phases to ensure that permanent implantation will work for you.

TEST PHASE

This phase is performed in the IGA procedure lab under local anesthesia. You will remain awake during the procedure. Prior to starting, you will be asked to sign a consent form authorizing the procedure.

You will then be escorted to a room, provided with a gown, and asked to change. A nurse or medical assistant will assist with preparation. You will lie on your stomach, and your back will be cleansed with a sterile solution. Sterile drapes will be applied to maintain a sterile field.

The physician will numb the skin using lidocaine, which may cause brief discomfort similar to dental numbing. Once the area is anesthetized, the physician will insert a needle and test stimulation to determine optimal lead placement based on your sensory feedback (typically described as tapping or vibration).

After placement, the leads will be secured to your back with tape and will remain external for the duration of the trial period. The trial typically lasts 72 hours but may extend up to 7 days. You will be provided with a bowel diary to document your responses, similar to the one completed prior to this test.

PREPARATION FOR YOUR PROCEDURE

- **Show the morning of your scheduled procedure.** You will not be able to shower during test phase (sponge bath only).
- **8 hours prior to the procedure, BEGIN A CLEAR LIQUID DIET. Do not eat any solid foods.** You may consume clear fluids including juice (apple, grape, strained orange, strained lemonade), tea, coffee (no milk or creamer), soft drinks, sports drinks (Gatorade, Powerade), clear broth or bouillon, Jell-O, and popsicles.
- **4 hours prior to your procedure, STOP ALL LIQUIDS. This also means NO water other than to take your medications**
- **Bring your PRE-TRIAL BOWEL LOG with you on the day of your procedure** This was given to you during your initial clinic appointment.
- You will be asked to **refrain from strenuous activity during the test phase.**
- **Do not lift anything heavier than five pounds.** Keep bending to a minimum.
- After lead placement, your removal procedure will be scheduled within 3-7 days with a nurse or medical assistant. This appointment involves the removal of the tape and leads. We will ask questions about how the test phase worked for you.
- You will then be referred to a surgeon for placement of stim device.
